The Term & Renewal: The term of the contract shall be 1 Year from **24-Mar-2023** till **23-Mar-2024** and may be renewed intact or amended by mutual consent. Upon such renewal all the provision of this agreement shall apply to the renewed duration.

Safety Policy: We provide our work force with proper uniform, hand gloves, face mask and other safety equipment to be used while duty. Insurance: In order to protect our clients from likely damages and losses while we do our service we have taken **Public Liability Insurance for US \$ Five Million.** In addition, our work force is covered under **Workmen's Compensation Policy** and all our vehicles are insured comprehensively.

Termination of Contract: Either party can terminate the contract with or without the permission of the other party by serving 30 days notice explaining their intention to terminate the contract with or without giving the reason, whatsoever, for such termination.

Additional Cleaning: If additionalcleaning is required, each job will be charged proportionately to the above agreed rate. Except for emergency, please provide 24 hours advance notice for cleaning requirements other than the scheduled cleaning jobs.

The First Party shall provide water and electricity required for the normal operation of the subject of services free of charges to the Second Party during the provision of the services at the site.

The First Party shall provide the Second Party the right of access to and exit from the property to perform the services as may be reasonably necessary to perform the services. The right of access includes the personnel, vehicle and equipment required for the provision of services.

The Second Party shall perform its works under this agreement in accordance with the standards applicable to the industry by strictly
